Software

- **NDA Data Structure Validator Tool** – identifies and validates NDA data structures and elements.
- **wizaRdry** – an R package that allows you to create NDA submission templates from REDCap, Qualtrics, etc. It ensures alignment with NDA data structures. Requires a Github account to access. Contact joshua.kenney@yale.edu.

Data Submission Update!

As we near the deadline for the first IMPACT-MH data submission cycle, the DCC wanted to provide some news regarding the submission progress. For the 2025 July NDA submission, the DCC was planning to collect data from 6 of the 8 sites. Through this process, we have worked together with each site to help assemble NDA-ready datasets using the tools we've developed. For data preparation, wizaRdry has worked seamlessly to not only validate and prep all site data, but also generate NDA-ready submission templates. Similarly, we were happy to see the data portal work well on the data collection and submission front.

We are pleased to announce that we have had great success with each site. **As it stands, 5 of the 6 submitting projects have had their data submitted to the NDA.** Thanks to everyone's hard work, the process has gone very smoothly, and we are excited to see more success in future cycles. Additionally, the feedback and communication we have received from the sites will help us sharpen the process even more for the next submission. Cycle 1 for IMPACT-MH has been exceptional, and we can't wait to see the project grow as a whole.
